PRODUCT DESCRIPTION

DURAPRO AW3696 is a polyvinyl acetate base adhesive with designed for cabinets, furniture, carpentry work and other indoor gluing projects. AW3696 has an excellent initial grip and reduced slip during assembly. Forms strong bonds on hardwood, softwood, plywood, natural wood composites, MDF, cardboard and other porous materials.

PREPARATION

Stir well before using. Adhesive, materials and room temperature should be above 18°C. Surfaces to be glued must be sanded smooth, clean and dry. Best bonds are obtained when moisture content of wood ranges between 8% and 12%.

APPLICATION

Pour directly from the bottle or apply using a glue brush, a glue applicator roller or a mechanical glue spreader to one of the surfaces. Spread glue to result in squeeze out when parts are assembled. Joints must be tight fitting. Clamp or press using sufficient pressure. Dries light translucent yellow. Allow to dry before sanding.

Assembly time: 10-20 minutes Clamp time: 30-60 minutes Drying time: 6-8 hours Spread rate: approx. 6 sq.m./L (240 sq.ft./gallon)

NOTE: Temperature, humidity, surface porosity and josite conditions can affect coverage and drying time.

ATTENTION

For applications requiring water-resistance, use our wood glues AW2539 Type 2, AW3466 Type 2 or AW0028 Type 1. Not recommended for structural applications (such as load-bearing parts in building structure).

Type 1, 2 and 3 refer to ASTM D-4317 Standard specification for polyvinyl acetate-based adhesives.

Clean hands, tools and excess adhesive with warm soapy water before the product dries. If glue has dried, use an adhesive cleaner/remover with caution. On bonded materials, scrape off and sand dried meticulously.

STORAGE

Store indoor in a cool, dry location between 10°C and 35°C. Keep container closed when not in use. Protect from freezing. Product is freeze-thaw stable down to -10°C. Prolonged or repeated cycles should be avoided.

SHELF LIFE

Shelf life is 18 months at room temperature in original unopened container.

DISPOSAL

Consult your municipality to dispose container and left-over in accordance with environmental regulations.
